You are invited to attend our **33rd annual Northwest Medical Laboratory Symposium** in Lynnwood, WA, October 18 - 21, 2017 (October 18 - 20 for the Exhibits) at the Lynnwood Convention Center. This meeting has the largest clinical laboratory product show in the Northwest in conjunction with multiple days of continuing education. Our exhibit hall in Lynnwood is expected to have an attendance of about 125 visitors per day. Because of the proximity to the metropolitan areas, we tend to attract walk-ins who visit the exhibits but are not registered for the scientific sessions. And the **good news is that we have not increased the base price of the booth! There is a demo van fee for those vendors who have a Full or Half booth. For Exhibitors with an Island or Mini-Island, there is no extra demo van fee.** Because of the size of the instrumentation in today's laboratories, the Exhibit Hall is becoming a popular means of exposure to the individuals with purchase power. We encourage all Exhibitors to also schedule off hours special demonstrations by appointment.

***In addition, we will be offering P.A.C.E.® credit for attendees answering a set of questions about products and information found only in the booths on the Exhibit floor. This encourages attendance at the Exhibits and allows attendees an opportunity to obtain P.A.C.E.® credit at no additional cost.***

***We are also planning a daily raffle, where folks need to go to your booth to talk with you to get a chance to win.***

Reserving your space before **June 1, 2017**, ensures your company's name in the programs mailed to over 3000 potential registrants throughout the Northwest. Booth location is determined by the received date of your registration. Your payment must be received by **September 15, 2017** to retain your space on the exhibit floor.

If you plan to bring an equipment demonstration van to exhibit your products, we will contact you for information about your vehicle size as we get closer to the meeting.

We will include a link to your company's website on the Symposium website. Your company may also support our meeting by sponsoring speakers, coffee breaks, or other NWMLS functions. Sponsors are acknowledged in the printed program, posted on our websites, and displayed on signs at the meeting.
